### Notice of Party Nomination Method for Constitutional Offices and Call to Caucus

On Wednesday, March 8, 2017, the Portsmouth Democratic Committee voted unanimously to approve Non-primary methods of nomination for the following Constitutional Offices.

#### The Assembled Caucus

**Commonwealth Attorney:** Candidates seeking the democratic nomination are required to pre-file their candidacy with Lisa Lucas-Burke, Nominating Committee Chair at 1214 County Street, Portsmouth, Virginia 23704 between the hours of 9:00 A.M. and 5:00 P.M., March 15 - 31, 2017. The package shall include a \$5,000 filing fee and signatures of 125 registered voters.

**Sheriff:** Candidates seeking the democratic nomination are required to pre-file their candidacy with Lisa Lucas-Burke, Nominating Committee Chair at 1214 County Street, Portsmouth, Virginia 23704 between the hours of 9:00 A.M. and 5:00 P.M., March 15 - 31, 2017. The package shall include a \$5,000 filing fee and signatures of 125 registered voters.

**Treasurer:** Candidates seeking the democratic nomination are required to pre-file their candidacy with Lisa Lucas-Burke, Nominating Committee Chair at 1214 County Street, Portsmouth, Virginia 23704 between the hours of 9:00 A.M. and 5:00 P.M., March 15 - 31, 2017. The package shall include a \$5,000 filing fee and signatures of 125 registered voters.

The Assembled Caucus for **Commonwealth Attorney, Sheriff** and **Treasurer** is Saturday, April 29, 2017 between the hours of 10:00 A.M. and 12:00 P.M. at I.C. Norcom High School, 1801 London Boulevard, Portsmouth, VA 23704.

#### The Unassembled Caucus

**Commissioner of Revenue:** Candidates seeking the democratic nomination are required to pre-file their candidacy with Lisa Lucas-Burke, Nominating Committee Chair at 1214 County Street, Portsmouth, Virginia 23704 between the hours of 9:00 A.M. and 5:00 P.M., March 15 - 31, 2017. The package shall include a \$5,000 filing fee and signatures of 125 registered voters.

The Unassembled Caucus for the **Commissioner of Revenue** is Saturday May 20, 2017 at the Main Library, 601 Court Street, Portsmouth, VA 23704 or Churchland Library, 4934 High Street West, Portsmouth, VA 23703 between the hours of 10:00 A.M. and 2:00 P.M.

The Caucus will be cancelled if only one (1) candidate files for each constitutional office. In this event, the Chair will publicly announce the cancellation and proclaim the persons properly filed as the duly elected nominee and the filing fee will be returned to the nominee.
